CCPA Privacy Notice

This notice is for California residents only, and it supplements the information provided in the Hospicereport Privacy Policy (which explains the information we collect and how we use/disclose it).

Information We Collect

We may collect information that identifies, relates to, describes, references, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or device ("personal information"). D. Commercial information.	Records of personal property, products or services purchased, obtained, or considered, or other purchasing or consuming histories or tendencies.	No
E. Biometric information.	Genetic, physiological, behavioral, and biological characteristics, or activity patterns used to extract a template or other identifier or identifying information, such as, fingerprints, faceprints, and voiceprints, iris or retina scans, keystroke, gait, or other physical patterns, and sleep, health, or exercise data.	No
F. Internet or other similar network activity.	Browsing history, search history, information on a consumer's interaction with a website, application, or advertisement.	Yes
G. Geolocation data.	Physical location or movements.	Yes
H. Sensory data.	Audio, electronic, visual, thermal, olfactory, or similar information.	No
I. Professional or employment-related information	Current or past job history or performance evaluations.	No
J. Non-public education information (per the Family Educational Rights and Privacy Act (20 U.S.C. Section 1232g, 34 C.F.R. Part 99)).	Education records directly related to a student maintained by an educational institution or party acting on its behalf, such as grades, transcripts, class lists, student schedules, student identification codes, student financial information, or student disciplinary records.	No
K. Inferences drawn from other personal information.	Profile reflecting a person's preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes.	Yes

We obtain the categories of information listed above (i) from you, whether directly or indirectly from activity on our site or from other interactions with us, and/or (ii) from third parties, such as ad networks or analytics services that interact with our site.

Use of Personal Information

HOSPICEREPORT collects and uses your personal information to operate the hospicereport.com site and deliver the services you have requested. We also use your personally identifiable information to inform you of other products or services available from HospiceReport and its affiliates. We may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.
